3. Your personal data will be processed in order to promote the scientific and didactic activities of the AGH University of Krakow, Try IT and the PP-RAI Conference;
4. Each of the Joint Administrators is responsible for:
processing of personal data in accordance with the principles set out in Article 5 of the GDPR;
 - 1) proper protection of personal data - in particular against access by unauthorized persons and unauthorized modification of data;
 - 2) exercising the rights of natural persons referred to in Articles 15-22 of the GDPR, taking into account possible restrictions resulting from the provisions of law;
 - 3) ensuring accountability in the implementation of obligations arising from the GDPR;

10. You have the right to lodge a complaint with the President of the Office for Personal Data Protection if you believe that the processing of your personal data violates the provisions of the GDPR.
11. Your personal data will not be processed in an automated manner, including profiling.
12. Giving your consent to the processing of personal data is a requirement necessary to participate in the Conference, and the consequence of not giving it will be the inability to participate in the Conference.
